WAR MEMORIAL BOARD OF TRUSTEES

REGULAR MONTHLY MEETING

Thursday, September 13, 2007

The Board of Trustees of the War Memorial of San Francisco met in regular session at 2:00 p.m. on Thursday, September 13, 2007, in the Trustees' Board Room, War Memorial Opera House, President Horn presiding.

APPROVAL OF MINUTES

President Horn called for approval of the minutes of the July 12, 2007 regular meeting of the Board. On motion of Trustee Davis, seconded by Trustee Pelosi, the minutes were unanimously approved.

PRESIDENT'S REPORT

Passing of former Trustee Armen Baliantz: President Horn reported with sadness the passing of former Trustee Armen Baliantz on August 2, 2007. President Horn stated that Armen Baliantz was appointed to the War Memorial Board of Trustees by Mayor Willie Brown in April 1997, and served as an enthusiastic and committed member of the Board until 2005, when she asked not to be reappointed due to health concerns. He said that Mrs. Baliantz was a dynamic figure in local, national and international arts, politics and social issues, and noted that her kind heart, generosity and "rack of lamb" were known and appreciated by everyone she encountered. President Horn stated that the War Memorial held a very special place in Armen Baliantz' heart, and that the War Memorial was fortunate to have her working on its behalf. President Horn asked that a letter be sent to Mrs. Baliantz' daughter, Jeannette Etheredge, extending the Trustees' condolences and sympathies, and he asked that today's meeting be adjourned in memory of former Trustee Armen Baliantz.

Opening of San Francisco Opera Season: President Horn reported that the San Francisco Opera opened its 2007 Fall Season on Friday, September 7, with an outstanding performance of *Samson and Delilah* and related opening night festivities. On behalf of the Trustees, President Horn extended best wishes to the Opera for a successful 2007 Fall Season.

Opening of San Francisco Symphony Season: President Horn reported that the San Francisco Symphony will open its 2007-08 Season on September 19, with a gala concert and festivities in Davies Symphony Hall. He noted that the Symphony opening, which usually takes place the first week in September, is occurring two weeks later this year, as the Symphony is currently on tour, performing concerts at summer music festivals in eight European cities. On behalf of the Trustees, President Horn extended congratulations to the Symphony on their successful European tour and best wishes for the upcoming 2007-08 Symphony Season.

<u>Improvements to Davies Symphony Hall</u>: President Horn stated that Trustees have received a copy of the September 4, 2007 letter from the San Francisco Symphony requesting approval to proceed with implementing enhancements to the Van Ness Avenue street level lobby in Davies Symphony Hall. He noted that attached to the Symphony's letter is a description of the proposed enhancements, which are consistent with the upgrades implemented by the Symphony in the Grove Street lobby for the 25th anniversary of Davies Symphony Hall in 2005. Ms. Murray stated that staff has reviewed and recommends approval of the Symphony's proposed enhancements.

Following discussion, and on motion of Vice President Bechtle, seconded by Trustee Pelosi, the following resolution was unanimously adopted:

Vince Rios Leaving American Legion War Memorial Commission: President Horn stated that Vince Rios, Secretary/Treasurer of the American Legion War Memorial Commission since 2002, has announced that he will retire at the end of September, and that he and his wife plan to relocate to Ft. Worth, Texas where they grew up. President Horn stated that Vince Rios has appeared before the Board of Trustees on numerous occasions during the last five years and has worked together with the War Memorial staff on many matters. On behalf of the Board, President Horn extended best wishes to Vince Rios and his wife in their retirement and relocation plans.
