In the fall of 2017, the Symphony first presented conceptual plans for the "Immersive Lobby Experience", featuring the installation of digital screens throughout the lobbies of Davies Symphony Hall, as well as interactive kiosks providing patrons with context and content related to the Symphony and the music being performed.

After much research and cost analysis, the project as presented was determined to not be financially feasible. However, the Symphony will present a reimagined project to the Building Committee and Board of Trustees next month. The project will include lobby column lighting, projections onto a kinetic installation over the grand staircase, and portable information displays placed throughout the lobbies. The proposal will include a request to fund the project through the facility enhancement fee.
